2. All students shall deposit their all fees (Tuition Fees, Hostel Fees, Mess Fees & Transport Fees) on or before the scheduled date for the respective programs. After completion of the due date of fee as mentioned above, the fine will be imposed (as per the University rule) up to 25 days. The fine would be calculated on daily basis and the students will deposit their fees with fine.
3. Students not depositing the dues within the above mentioned due date (with & without fine) which includes tuition fees, hostel fees, mess fees & transport fees, as applicable, in such case their names will be struck off from the respective services and will be debarred from attending any classes, appearing the examinations both internal assessments & final examination if tuition fee not paid. No credit for attendance would be given to students during the strike off period. If the student wants to continue his/her study, has to take readmission by depositing the re-admission fee and the amount whatever is pending/due.

4. The students pursuing their studies through bank loans and processed through the SSU must pay all fees (tuition fees, hostel fees, mess fees & transport fees) within 15 days from the publication date of the previous semester's result. Non-payment of fees within the due date as specified above will amount to the imposition of fines or any other norms as per the rules of the SSU.
