1. Policy Overview:

1.1. This policy establishes the objectives and parameters of the University investment and how Sri Sri University is embracing environmental, social and governance (ESG) factors within its investments, reflecting the ambitious sustainability agenda within the Sri Sri University.

2. Scope of the Policy:

2.1. The investment policy is applied to the University funds. To reflect that; this is a constantly developing area, the sustainable investment policy will be reviewed regularly, by the Director of Internal Quality Assurance Cell (IQAC) of Sri Sri University.

3. Sustainable Investment Strategy:

- 3.1. Sri Sri University is committed to reducing its carbon footprint. In line with this target, the University is committed to ensuring that its investments are according to the highest ESG standards. The strategy recognizes that a responsible approach to sustainability and financial returns are not mutually exclusive and that a sustainable approach to environmental and social issues are more effective stewards of long-term capital. The policy states that the University will make investments towards:
- 3.1.1. Maintaining biodiversity of the University campus which includes diverse flora and fauna
- 3.1.2. Promote and provide walkways within the campus to reach to different blocks and reduce carbon footprints
- 3.1.3. Provide transport facility from hostels to the academic blocks and return.
- 3.1.4. Introducing courses within the syllabus that sensitize the student community towards environmental sustainability and environmental relates issues.

- 3.1.6. Carrying out research that promotes environmental safety and sustainability
- 3.1.7. Segregate and disposing-off laboratory wastes and effluents.
- 3.1.8. Recycling of waste water and reusing it for gardening and other proposes

- 4.1. Tobacco, alcohol or any intoxicants
- 4.2. Weapons
- 4.3. Environment harming wastes
- 4.4. Gambling
- 4.5. Coal and Tar Sands
